# Manhattan

## Median Sales Price

The median price per square foot for East Side townhouses rose 26% over the past year to \$1,740. During the same period, the East Side median price declined 14% from the second half of 2005 to \$6,000,000, a figure attributable to the closing of a greater proportion of townhouses smaller in size. An increase of 9% Downtown in the second half of 2006 resulted in a higher median price of \$3,797,500 when compared to a year ago. A positive gain of 9% was also seen in Northern Manhattan during this time, with the median price achieving \$1,062,500 in the latter half of 2006. There were not enough West Side townhouse sales in the second half of 2006 for a valid comparison.


